# Objectives and investment policy

The objective of the Fund is to add value versus the benchmark (MSCI Daily TR Net Europe USD converted in Euro) through a structured, research-driven process with controlled risk.

The Fund is actively managed. The Fund's investment decisions are discretionary as they are determined by a market index. The Fund mainly invests in listed stocks that are traded on the stock exchanges of the benchmark countries. To a lesser extent (up to 20% of its assets), investment in stocks listed on stock exchanges of countries outside the benchmark is permitted, and with the inclusion of emerging European countries. Derivatives should be used only for the purpose of protecting the Fund from the risk of loss arising out of market prices movements or as agreed with the management company.

The Fund may distribute a percentage of its net assets, however, no distribution will be made if such distribution implies that the net assets of the Fund fall under one million two hundred and fifty thousand Euros (1,250,000 Euros).

Investors can buy or sell shares of the Fund each day on which banks are open for a full day of business in Luxembourg.

#### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.


